


ARTICLE XII - INDEMNIFICATION

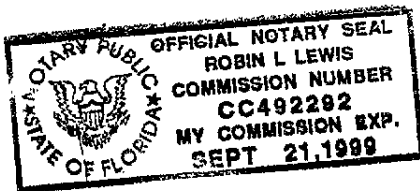
