

The number of shares the corporation is authorized to issue is ONE HUNDRED (100). All 100 shares are common stock.


ARTICLE FIVE

The initial registered agent is Candyce M. King. The initial registered office of the corporation is 2211 Park Street, Jacksonville, FL 32204.


