Name

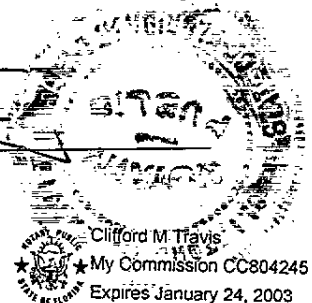
