ARTICLE I - NAME

The name of this corporation is **Palm Beach PR, Inc.**

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

ARTICLE IX - INDEMNIFICATION

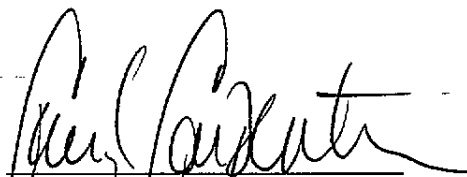
The corporation shall indemnify any Officer or Director or any former Officer or Director to the full extent permitted by law.
