ARTICLE XI.



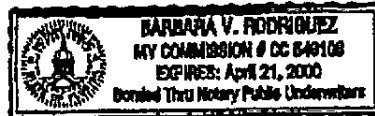
