ARTICLE ONE
NAME AND MAILING ADDRESS OF CORPORATION

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

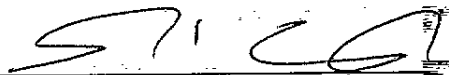

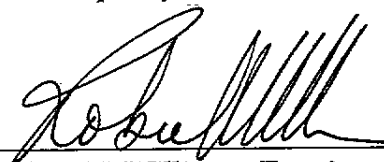
