THE UNDERSIGNED, for the purpose of forming a corporation, under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

<u>ARTICLE I</u> NAME OF CORPORATION

The name of the corporation is MARLIN OF THE KEYS, INC., and the mailing address is 364 King Avenue, Key Largo, Florida 33037.

<u>ARTICLE II</u> DURATION


