We, the undersigned, hereby make, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

Name of Corporation

The name of the Corporation shall be JAJAM CORPORATION. The address is 805 20th Street, Vero Beach, FL 32960.

ARTICLE II

Purpose of Business

The Corporation is organized for the purpose of engaging in any activity permitted under the laws of the United States or of this State.
