ARTICLES OF INCORPORATION OF MILDRED CAMPBELL TRANSCRIPTIONS, INC.

The undersigned incorporator of these Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporation Act and does hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME AND PRINCIPAL OFFICE

The name of this Corporation is Mildred Campbell Transcriptions Inc. The Corporation's principal office is located at 8303 75th Avenue North, Largo, Florida 33777.

ARTICLE TWO DURATION

The Corporation is to exist perpetually.

ARTICLE THREE PURPOSE
