ARTICLE I - NAME

The name of the corporation shall be R.R.D.T Corp.

ARTICLE II - DURATION

This Corporation is to exist perpetually

ARTICLE III - PURPOSE

This Corporation is organized to engage in any act or business permitted under the laws of the

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with a par value of one
dollar (\$ 1.00) per share.

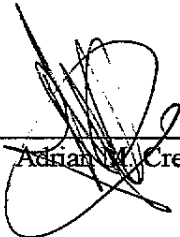
