ARTICLES OF INCORPORATION OF METROTILE & STONE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Office Florida Business Corporation Act, hereby adopts the following Articles of Incorporation, pursuant to the laws of the State of Florida.
