ARTICLES OF INCORPORATION OF

SOR AND AND BOOK STANS FORTRESS PROTECTION AGENCY, INC. The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE II Name

The name of this corporation shall be Fortress Protection Agency, Inc.

ARTICLE II Term of Existence and Fiscal Year

This corporation shall begin existence on the date of filing of these Articles of Incorporation with the Secretary of State of the State of Florida, and shall have perpetual existence thereafter. This corporation shall have a fiscal year beginning January 1 and ending December 31 of each year.

ARTICLE III Nature of Business
