ARTICLES OF INCORPORATION OF THE SIGNATURE STRAWBERRY SALON & DAY SPA, INC.

The undersigned incorporators, being competent to contract, subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the state of Florida ()

ARTICLE I - Name

The name of this corporation shall be:

ARTICLE II - Principal Office and Mailing Address

ARTICLE III - Initial Registered Office and Agent
