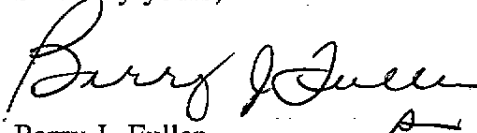

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST
NAME**

The period of duration of the corporation is perpetual commencing on the date of execution of these Articles of Incorporation.

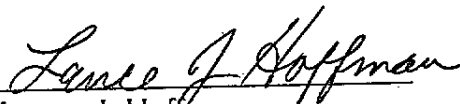

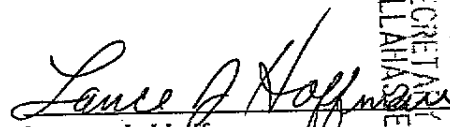
