

**ARTICLES OF INCORPORATION OF
SWEENEY ENTERPRISES, INC.**

THE UNDERSIGNED, acting as sole incorporator of **SWEENEY ENTERPRISES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

Initial Board of Directors


The corporation shall have one director who shall manage the corporation. The initial director shall be Alfred Evans Sweeney.
