# ARTICLES OF INCORPORATION NAME OF CORPORATION: BLUE-LINE TRADING INC.

**THE UNDERSIGNED,** acting as the Incorporator of a corporation under the "Florida General Corporation Act," adopts the following Articles of Incorporation for such Corporation.

### ARTICLE I CORPORATE NAME

### BLUE-LINE TRADING INC.

#### NATURE OF CORPORATE BUSINESS

This Corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

### ARTICLE III CAPITAL STRUCTURE

- [A] Capital Stock: The Corporation is authorized to issue and have outstanding at any one time an aggregate number of SEVEN THOUSAND FIVE HUNDRED (7,500) shares of stock having a par value of ONE DOLLAR (\$1.00) per share.
