ARTICLE VII

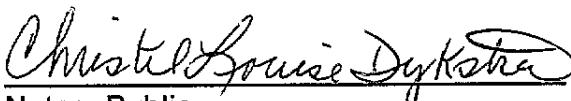

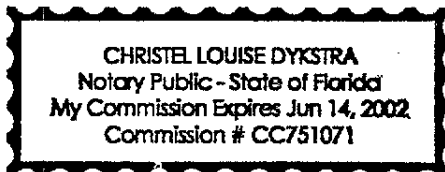
