ARTICLE I - NAME

The name and initial mailing address of the principal office of this Corporation is PM Transport, Inc., 22290 S.W. 162 Avenue Goulds, Florida 33170.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.
