The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is: A ADDRESS IMPROVEMENT, INC., and the principal physical address of this corporation is 9726 Geiger Road, Jacksonville, Florida 32246. ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and/or all lawful business.

ARTICLE IV - CAPITAL SHARES


ARTICLE IX - AMENDMENT

The date of commencement of corporate existence shall be May 1, 1999.


