The undersigned, a subscriber to these articles of incorporation, a natural person competent to contract, hereby presents these articles for the formation of a corporation pursuant to the laws of Florida.

1. The name of the corporation shall be : Computer Telecom, Inc.
The address of the corporation is: 15751 Sheridan Street, Suite 301, Fort Lauderdale , Florida 33331.
2. The corporation shall be organized to have a maximum of 100 shares of stock outstanding at any one time. The shares of the outstanding stock shall have a par value of \$ 1.00 per share.
3. The corporation may engage in any activity or business permitted under the laws of the State of Florida.
