The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation shall be ADAMS TRANS-AID CORP.

ARTICLE II

NATURE OF BUSINESS: The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III

CAPITAL STOCK: The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of ONE DOLLAR (\$1.00) par value common stock. TERM OF EXISTENCE: This corporation shall have perpetual existence.

TAXATION: It is intended that this corporation shall file for taxation under Subchapter S provision of the Internal Revenue Code.

ARTICLE VII

INITIAL REGISTERED AGENT AND OFFICE: The street address of the initial principal office of this corporation is 3961 E. River Drive, Fort Myers, Florida 33916, and the name of the initial registered agent of this corporation is THOMAS F. ADAMS, and the address of the registered agent is 3961 E.
