THE PERIOD, TERM AND DURATION IS PERPETUALITY.

ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS BUSINESS AS A FULL EXPORT COMPANY, WHEREIN, WE WILL PROVIDE A WHOLE SALE EXPORT COMPANY TO CARRY AND SALE SHOES AND RELATED PRODUCTS OF ALL KIND IE, SHOES BAGS BELT AND OTHER LEATHER GOODS.
