This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Acct.

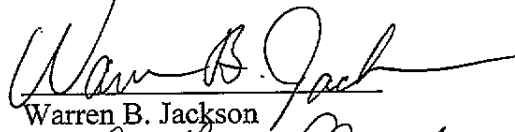
