ARTICLE I NAME & ADDRESS:

The name of this corporation is UNITED CONSTRUCTION GROUP OF MIAMI, INC. and the address is 20 NW 135 AVENUE, MIAMI, FLORIDA 33182.

ARTICLE II DURATION

This corporation is to exist perpetually and it shall commence its existence on the date of filing of the Articles of Incorporation with the Secretary of the State of Florida.

ARTICLE IX INDEMNIFICATION
