The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

- 1. NAME. The name of the Corporation is JACK OF HEARTS RECORDING CORP.
- 2. <u>PRINCIPAL OFFICE/MAILING ADDRESS</u>. The principal office and mailing address of the Corporation is 7026 Carissa Circle, West Palm Beach, Florida 33406.
- 3. <u>SHARES</u>. The number of shares the Corporation is authorized to issue is one thousand (1000) shares. The par value for the authorized shares is One Dollar (\$1.00).
- 4. PREEMPTIVE RIGHTS. 
