ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF KIUBO NETWORK, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is KIUBO NETWORK, INC. (the "Corporation"), Charter H99000009703.
