Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is KIUBO NETWORK, INC. (the "Corporation"), Charter H99000009703.

2. The Amendment to the Articles of Incorporation described herein was adopted by the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on November 15, 1999 in the manner prescribed by Section 607.1003 of the Act.

3. Article 2 of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article 2, as follows:

"Article 2: CAPITAL STOCK: The number of shares which the corporation has authorized to be outstanding at any one time is 50,000,000, with a par value of \$0.01 per share."

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
