

The number of directors constituting the initial Board of Directors of this corporation shall be one (1).



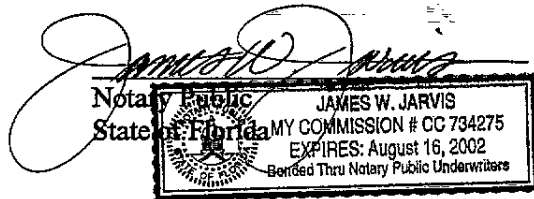
