## **ARTICLE I - NAME**

The name of the corporation is Courtesy Circle Farms, Inc. (hereinafter called the "Corporation").

#### **ARTICLE II - PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

The Corporation shall have two (2) directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one.
