Name of Corporation

The name of this corporation is DEALERSHIP MANAGEMENT & CONSULTING, INC.

ARTICLE II  
Corporate Existence

This corporation shall have perpetual existence.


controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.
