**ARTICLE I - NAME**

The name of this corporation is TAX (INCOME) PROBLEM SOLVERS, INC.

**ARTICLE II - NATURE OF BUSINESS**

This corporation may engage in any activity permitted under the laws of the United States and of the State of Florida.
