ARTICLES OF INCORPORATION

OF

SPEARS SMALL ENGINES & POWER EQUIPMENT, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. **NAME:** The name of the corporation shall be **SPEARS SMALL ENGINES & POWER EQUIPMENT, INC..**
2. **PRINCIPAL OFFICE:** The principal office of the corporation shall be located at 3083 Crawfordville Highway, Crawfordville, FL 32327.
3. **PURPOSE:** The purpose of the corporation shall be to perform any act which is legal under the laws of the State of Florida and of the United States of America.
4. **DURATION:** The duration of the corporation shall be perpetual or until such time as the corporation may be dissolved in accordance with the laws of the State of Florida.
5. **MANAGEMENT:** The affairs of the corporation shall be managed by a President, Secretary and Treasurer, who shall be elected on an annual basis by the stockholders of the corporation. The said offices may be filled by one person. The officers and stockholders of the corporation may be indemnified by the corporation for any act that they shall perform on behalf

of the corporation. The initial officer of the corporation shall be LAMAR SPEARS who shall hold the offices of President, Secretary and Treasurer.

6. STOCK: The corporation is authorized to issue up to 100 shares of stock with a par value of \$5.00 per share, all of which shall be of the same class.

7. INITIAL REGISTERED AGENT: The name and address of the registered agent of the corporation shall be LAMAR SPEARS, 3083 Crawfordville Highway, Crawfordville, FL 32327.

8. INCORPORATOR: The name and address of the incorporator of this corporation is LAMAR SPEARS, 3083 Crawfordville Highway, Crawfordville, FL 32327.

9. AMENDMENT: These Articles of Incorporation may be amended at any time by a majority vote of the stockholders of the corporation.

10. EFFECTIVE DATE: These Articles of Incorporation shall be effective upon their filing with the Florida Department of State, Division of Corporations.
