ARTICLES OF INCORPORATION

OF

SPEARS TRACTORS/POWER EQUIPMENT SALES, RENTALS & REPAIRS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:
