KNOW ALL MEN BY THESE PRESENTS: that the undersigned, a natural person competent to contract, for the purposes of forming a corporation under the laws of Florida, does hereby certify as follows:

## ARTICLE I. NAME

The name of this corporation is Haven Rehabilitation, Inc. Street address: 637 Avenue A, S.W., Winter Haven, Florida 33880.

#### ARTICLE II. NATURE OF BUSINESS


