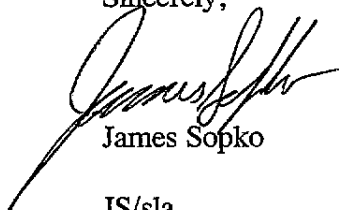

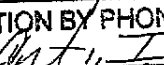
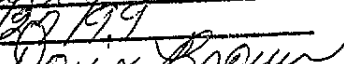

The effective date of this corporation is April 20, 1999.

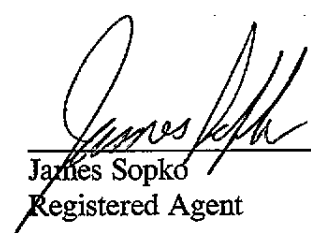
