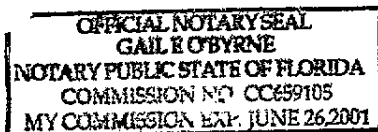
1. The name of the corporation shall be: JIN SHIN DOJO, INC.
