

ARTICLE ONE

The name of the corporation is **DATA SOFTWARE SOLUTIONS, INC.** The principal address of the corporation is: 2950 NW 106TH AVENUE SUITE 6, SUNRISE, FLORIDA 33322.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**
