## ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for formation, liability, rights, privileges and immunities of a corporation for profit, does hereby certify as follows:

## ARTICLE I NAME

The name of this corporation shall be JANICE APPEL, INC. The mailing address of the corporation shall be 8370 Wingate Drive, #710, Sarasota, Florida 34238.

### ARTICLE II TERM OF EXISTENCE

This corporation shall have perpetual existence.

# ARTICLE III PURPOSE OF CORPORATION
