FIRST: Amendments adopted:

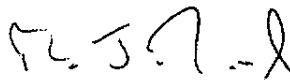
1. That we constitute all of the incorporators and members of the Board of Directors of **First Class Transport, Inc.**, and that we adopt and approve the amendments of the Articles of Incorporation as herein set forth.
2. That the corporation has issued no shares.
3. That we hereby adopt and approve the following amendments of the Articles of Incorporation:

FOURTH: The amendments were adopted by the incorporators without shareholder action and shareholder action was not required.

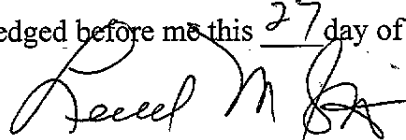
