I am writing to you today, 10/31/2000, with regards to the notice that I received from your office. It stated that my corporation had been dissolved because I did not file a Uniform Business Report. I know you must hear this often, but I never received any such notice, nor did I even know I was required to file one. I have only been in business a little over a year, 17 months to be exact. I had no knowledge such a form or filing existed.

I sincerely ask for a one time exception or waiver with regards to this. I am not making excuses or asking for special treatment, just a little human compassion. My mother passed away on May 2nd of this year after a long bout with cancer, she was only 54. My wife and I took care of her in our home until she died. I cannot believe that I would have ignored a notice that was sent in January, let alone ignore another notice that was sent in June 2000. I moved my residence in May after my mother died as we no longer wanted to live there with those memories. Could it be possible that the new renters received and threw it out? I never received it.

I implore whoever makes these decisions to please waive this and renew my corporation for the \$150.00 fee. I'm a very small company with only one employee. I do everything I'm supposed to do, file my taxes on time, carry the right insurance, etc.. The fee of \$750.00 for an oversight on my part seems very heavy. I assure you that now that I am aware of such a form it will never happen again. Who in their right mind would rather pay \$750.00 than \$150.00?

In closing, please consider my request and grant me the one time exception? With God as my witness, I never received nor ignored any request. Thank you for your consideration.
