ARTICLES OF INCORPORATION OF

LERVAAG CONSULTING, INC.



ARTICLE I - NAME

The name of this corporation is LERVAAG CONSULTING, INC. and is located at 876 DuPont Street, NE., Palm Bay, FL 32907.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.
