ARTICLES OF INCORPORATION

OF BLUE RIBBON VENDING, INC.

The undersigned, for the purpose of forming a corporation under Figure Florida

General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Corporate Name. The name of this corporation is **BLUE RIBBON VENDING**, **INC.** The initial mailing address of this corporation is <u>142 Crabapple Lane</u>, St. Marks, Florida 32355.

ARTICLE II

Duration. The duration of this corporation is perpetual.

ARTICLE III

Purpose. The general purpose for which the corporation is organized are the following:
