
Per my conversation with Robin of your office yesterday, I am enclosing a completed annual report with \$150 which I hope that you will accept as the full filing fee for this corporation due to the following extenuating circumstances.

First, we never received the original report in February(?) and your records report that it was returned by the Post Office. The address in your database does not include my floor (second) and the report prompting the apparent return by the Post Office. The return of those materials is surprising inasmuch as I routinely receive mail that omits the floor number; I have been at this location for over five years; my office is listed on the directory in the lobby and there are only three floors in the building. I can therefore only surmise that the letter carrier on the day of delivery was new or not doing his job very well.

I have a history, as registered agent for this and other corporations of paying promptly (see document nos. L75715 and P99000020338, for example). I may have to personally incur the additional \$400 filing fee if you do not waive it and would therefore greatly appreciate your consideration in this regard.
