ARTICLE I - NAME

The name of this Corporation shall be

H.M.F. DRYWALL FINISH, INC

ARTICLE II - GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock authorized to be issued by this Corporation shall be:

Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. ARTICLE V – TERM OF CORPORATE EXISTENCE

The Corporation shall have perpetual existence.

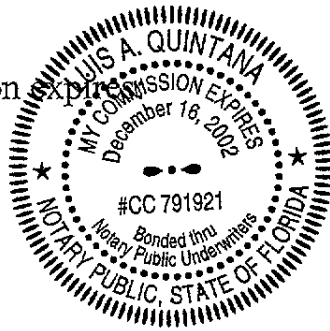
