ARTICLES OF INCORPORATION

The undersigned natural persons, each of whom is licensed or otherwise legally authorized to practice the profession of Dentistry in the State of Florida, hereby associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:

ARTICLE I

The corporate name is Arthur T. Bruggisser D.D.S., P.A.

ARTICLE II

The purpose of the corporation is to practice the profession of Dentistry. This corporation is organized for the following purposes:

- a) To engage in the practice of Dentistry as a professional corporation and to carry on services incident thereto. The practice of Dentistry is the sole and exclusive professional service to be rendered by this corporation.
- b) To own property, enter into contracts and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- c) The professional services of this corporation shall be carried out only through officers, employees and agents, each of whom has been licensed and is duly authorized to practice in, the State of Florida.

ARTICLE III

CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 1,000 shares. Such shares shall be of a single class of common stock, and shall have a par value of \$.50 per share.

ARTICLE IV

AMOUNT OF CAPITAL TO BEGIN BUSINESS WITH

The amount of capital with which the corporation will

begin to practice the profession of Dentistry is
not less than Five Hundred Dollars (\$500.00).

ARTICLE V

EXISTENCE OF CORPORATION

The corporation shall have perpetual existence.

ARTICLE VI

PRINCIPAL PLACE OF BUSINESS

The initial street address of the corporation's principal office is 599 South Federal Highway, Dania, Fl. 33004, and the mailing address shall be the same.

ARTICLE VII

NUMBER OF DIRECTORS

The number of directors of this corporation shall be no less than one (1).

ARTICLE VIII
