ARTICLES OF INCORPORATION

OF

J. KNOX ENTERPRISES, INC.



THE UNDERSIGNED, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation is: J. KNOX ENTERPRISES, INC.

The period of its duration is perpetual.
