ARTICLE I - NAME

The name of this corporation is AFFOURI CORP. The principal office and mailing address of this corporation is: 1133 S. University Dr., #202, Plantation, FL 33324.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock which shall be designated "Common Shares".

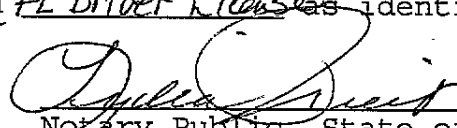
