**ARTICLE I**

**NAME OF CORPORATION**

The name of the Corporation is STICKER STATION, INC.

**ARTICLE II**

The principal office of the Corporation is located at 1421 W. Pine Hills Road, Orlando, Florida, 32808.

**ARTICLE III**

The general nature of the business to be transacted by the Corporation is to engage in any and all business permitted under the laws of the State of Florida.

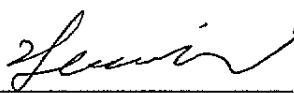

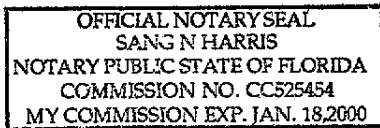
