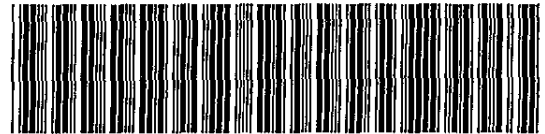

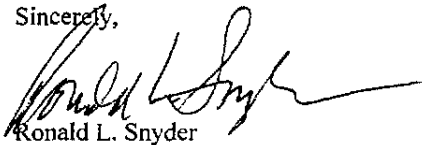
RE: Ron Snyder Investments, Inc., a Florida Sub-S Corporation / Voluntary Dissolution
