**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

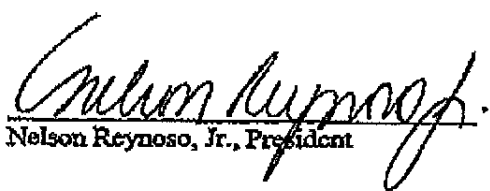
1. The name of the Corporation is PRO-WALL, INC.
